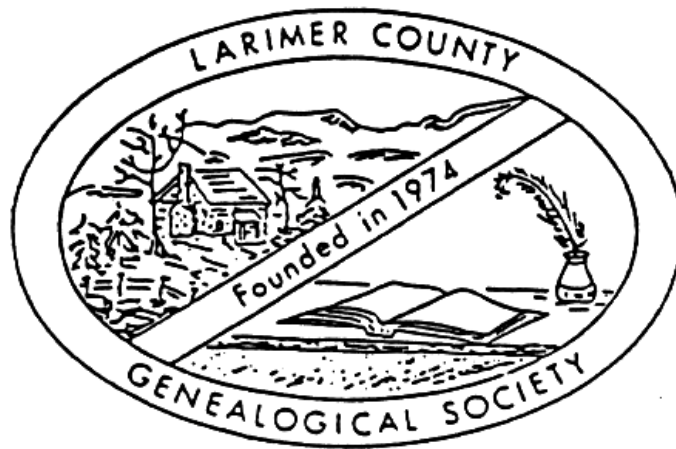

## Preface

Loveland Burial Park was started in 1912 by Wilbert Stiles, a wealthy land and water owner. The first burial in the Park was that of Willard Ranson in 1912. Mayor Archibald Foster appointed a Cemetery Committee in 1919 to evaluate adding the Loveland Burial Park to the city's other burial park, Lakeside. As a result of the committee's actions the city bought the park from Mr. Stiles. The Park has expanded from its original 13 acres to its present size, about 30 acres over time.

The research for this book started in 1989. A group from the Larimer County Genealogical Society and a Boy Scout troop walked the cemetery. They soon realized that there were a large number of unmarked graves; therefore they included information from the lot records. They completed the acquisition of the information and the project was shelved. In early 2001, the society resurrected the project and decided to update the information to December of 2000. We have used all of the records that the cemetery has to make the information complete and as accurate as possible; but because the records prior to City ownership are incomplete and the current records are not up to date, we were not able to get information on all burials.

In addition to the deceased name we have tried to include grave location, birth date, death date, and any information of genealogical significance. When we were unable to find information we have left the field blank. In some cases the tombstones have extensive poetry on them. We have not included this information.

Of special concern are women's surnames. We recognized that there were many cases where the tombstone did not accurately reflect the legal surname at the time of death. The legal name is required to obtain a death certificate. We decided to use the surname from the lot records: these are the names from the burial permit and should be the legal name. To enable the researcher to link women to others with the same surname who were buried adjacent to one another we have used s/s to indicate that two or more names occur on the same marker. Example George Eisenach is buried next to M. Barbara (Eisenach) Walker. The entry for George includes the comment "see M. Barbara (Eisenach) Walker". The entry for M. Barbara (Eisenach) Walker reads "see George Eisenach". When two people share a common marker the entries are like "Abrams, Fern I. s/s Frank W. Abrams." The usage of see or s/s does not imply any degree of relationship; it only indicates the sharing of a tombstone.
